Bully Free Future (BFF) Youth Summit WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT



1. In consideration for receiving permission to participate in the Bully Free Future (BFF) Youth Summit ("the Event") on Saturday, April 11, 2015, I hereby release, waive, discharge and covenant not to sue the Operation Peace of Mind,

West Dallas Community Church or any of their officers, members, servants, Agents and employees (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in the Event, or while in, on or upon the premises where the Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Event. If I am signing this on behalf of an organization, I attest that I have authority to do so, and agree that my signature covers all persons involved with the festival on our behalf.

- 2. I am fully aware of risks and hazards connected with being on the premises and participating in the Event, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the Event, and I hereby elect to voluntarily participate in the Event, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the Event, whether caused by the negligence of releasees or otherwise.
- 3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs, including reasonable attorney's fees and expenses, they may incur due to my participation in the Event, whether caused by the negligence of any or all of the releasees, or otherwise.
- 4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above named releasees.

In signing this release, I acknowledge and represent that:

- I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
- No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
- I am at least eighteen (18) years of age and fully competent; and
- I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

<u>Set Up</u>: Vendors and Non-Profit Organizations are encouraged to set up on Saturday, April 11, 2015, from 8:30am until 9:30 am. *Please check in at the registration area to be directed to your space*.



All vehicles must be moved to the designated parking area by 9:30 am and will not be allowed to re-enter until 3:00 pm on the day of the summit.

Additionally, please remember the following rules set by the West Dallas Community Church in order for us to use their space:

- * There is electricity available, however not all booths will have access (reservation is required).
- * Each vendor receives 1 table and 2 chairs (tables will be either 6ft or 8ft and will have a black plastic table cloth; however, feel free to bring your own table cloth)
- * The field and our event are alcohol free. Violators of this policy will be escorted from the event and will not be allowed to re-enter.
- * Any participant that has liability insurance available must provide a copy with their application. It should name the following as additional insured: Operation Peace of Mind and West Dallas Community Church.
- * All participants must sign and submit the Hold Harmless Agreement with the application.
